Nevada's labor force grows in February; Unemployment rate decreases

CARSON CITY, NV - According to the Nevada Department of Employment, Training and Rehabilitation's (DETR) February 2024 economic report, Nevada's unemployment rate decreased by 0.1 percentage points from January to February and now sits at 5.3 percent. The labor force in the state grew by 234. The state has seen growth in its labor force every month for over a year.

Metropolitan Statistical Area (MSA) Employment (Seasonally Adjusted):

- Las Vegas employment increased by 1,500 jobs (0.1%) since January, an increase of 34,900 jobs (3.1%) since February 2023.
- Reno employment had a decrease of 200 jobs (-0.1%) since January, an increase of 6,500 jobs (2.5%) since February 2023.
- Carson City employment had a decrease of 300 jobs (-0.9%) since January, an increase of 500 jobs (1.6%) since February 2023.

"This report shows a slight moderation in both our employment and unemployment data, with Nevada's employment growth rate slowing to 3.4% and the unemployment rate declining slightly to 5.2%. Nevada also has a higher concentration of unemployment due to individuals entering the labor market, pushing Nevada's labor force participation rate back above the national average." said David Schmidt, Chief Economist.

Nevada Statewide & Metro Area Labor Market Overview February 2024

Published on March 21, 2024

In February 2024, the seasonally adjusted unemployment rate in Nevada decreased by 0.1 percentage point and now sits at 5.2 percent. The labor force in the state once again grew (this time by only 234) and the number of unemployed individuals in the state went down by about 1,000. On the other side of things, the number of employed individuals went up, increasing by around 1,200.

On top of the growth in the number of employed individuals, the state also saw growth in its total number of jobs. The total non-farm employment in Nevada increased by about 2,900 jobs overall. Administrative and Waste Services, and Transportaion, Warehousing, and Utilites added the highest number of jobs over the month. These industries added 3,100 and 1,100 jobs, respectively.

The Las Vegas MSA saw an increase equivalent to 1,500 jobs (or 0.1%) over the month. Meanwhile, the Reno MSA saw a decrease of 200 jobs (or -0.1%). Finally, the Carson City MSA saw a decrease of 300 jobs (-0.9%).

Current Employment Statistics (CES)

Total nonfarm employment increased by 2,900 jobs from January to February, a growth rate of 0.2%. Since February 2023, total nonfarm employment increased by 51,200 jobs, or 3.4%. 



Local Area Unemployment Statistics (LAUS)

Figures for our unemployment estimates come from the Local Area Unemployment Statistics (LAUS) program sponsored by the (<u>BLS</u>). Nevada's unemployment rate was 5.2 percent in February, decreased by 0.1 percentage points from 5.3 percent in January, and was unchanged from 5.2 percent in 2023, seasonally adjusted. The number of unemployed individuals decreased by 1,001 from January to a current level of 83,820 people, which increased by 1,878 unemployed people since 2023. The labor force in Nevada is currently 1,614,454 people, which increased by 234 people from January, and increased by 24,543 people since 2023.




Unemployment Rate State Rankings (Prior Month's Data)

According to the Bureau of Labor Statistics, Nevada had the highest unemployment rate in the nation for the month of January 2024, at a figure of 5.3 percent. This is 0.1 percentage points higher than the second highest, which was observed in California.




Employment State Rankings (Prior Month's Data)




State of Nevada Industry Employment seasonally adjusted
