Reno MSA Compares Favorably to Others in terms of Private Sector Employment Growth: Has Average Wages, High Cost of Living

- Information obtained through the Quarterly Census of Employment and Wages (QCEW) Program provides a nearly complete job count based upon quarterly wage records submitted by employers whose employees are covered under the Unemployment Insurance System. As a result, historical information is subject to minimal, if any, revisions. This data encompasses jobs in all fifty states plus the District of Columbia. Because generating this information is a time-consuming process, it is only available with a 4-5 month lag.
- These cities were chosen on the basis of being of similar population (2018) and/or geography to the Reno-Sparks Metropolitan Statistical Area (MSA). The table above is a comparison of private sector job growth during the periods; first quarter of 2018 to first quarter of 2019 and first quarter of 2014 to first quarter of 2019.
- The Reno MSA grew by four percent from first quarter of 2018 to first quarter of 2019 which ranks relatively high
 in comparison to other MSA's nationally. From first quarter of 2014 to first quarter of 2019, Reno ranks fifth
 suggesting an overall trend of strong growth.
- For the period, first quarter of 2014 to first quarter of 2019, eight of the ten fastest growing MSA's are located in the Western United States.
- From first quarter of 2014 to first quarter of 2019, the fastest growing industries in the Reno MSA were Natural Resources/Mining and Manufacturing.

- The table above shows the average weekly wage for private sector employment as of first quarter of 2019, how it ranks amongst the 381 MSA's, and how it ranks when it comes to cost of living. The average weekly wage for the Reno MSA saw an 3.3% increase over the same period in 2018. Reno ranks 111th of 381 which places it in the top one third. The highest wage level is found in the San Jose MSA at \$2839 and the lowest in Brownville, TX at \$582.
- Reno is 38th highest in terms of cost of living and 40th in housing cost. All eight MSA's are in the bottom half of the rankings which suggests a relatively high cost of living. The highest cost of living is found in New York (Manhattan), NY at 242.5 and the lowest in Harlingen, TX at 73.8. When one compares the rankings above with respect to wages and cost of living, the spread between the two rankings ranges from +202 (Asheville, NC) to -73 (Beaumont, TX) with Reno coming in at 73.
